Check in: No earlier than 4:00 PM on Saturday, June 24, 2023. Must be checked in by 9:00 AM on Sunday, June 25, 2023. Exhibitors must check in with the superintendent immediately upon arrival. Notify Superintendent of special needs on entry form.

Show Entries: Use the Boer Goat Entry Form. Be sure to sign the Release & Waiver form on the back. Entries must be filled out completely and postmarked on or before Monday, June 12, 2023. Please put entries for shows 1, 2 and 3 on separate entry forms.

Exhibitor pass: \$15.00 (required for each exhibitor) Each owner is required to fill out a separate entry form and purchase an exhibitor pass. No refund on entry fees.

Rules and regulations: All animals will be released after the show. PENS MUST BE CLEANED BEFORE LEAVING FAIRGROUNDS. Anyone not cleaning their pens will not receive premiums. Due to the high cost of postage, all premium checks are to be picked up in the secretary's office before the exhibitor leaves the fairgrounds. If the check is not picked up, the exhibitor will forfeit their premium check to the fair association. A social security number is required for the release of the check. If you would like your check mailed to you, please bring a self-addressed, stamped envelope to the fair secretary's office at check-in. ABGA Rules shall govern. All animals entered in the ABGA Sanctioned classes must be registered with the ABGA. IMGA and ILWS rules shall apply to their respective shows. Exhibitors must show original or online certificates of registration and match tatoos. No tattooing at the show. Animals with illegible tatoos or tatoos not matching their registration certificate will be excused.

No exhibitor may receive more than two premium monies in any one class. When coming to the fair, enter at the northeast gate of the fairgrounds. Market animals must show with their milk teeth. Goats with missing milk teeth or eruption of permanent teeth will be disqualified. Tags and tatoos must match weight card. The Illinois Humane Care for Animals Act prohibits physical mistreatment of animals. Persons mistreating goats will be prohibited from exhibiting and/or lose their award.

THE SUPERINTENDENTS RESERVE THE RIGHT TO EXPEL PERSONS FROM THE SHOW FOR UNETHICAL OR UNSPORTSMAN-LIKE CONDUCT.

Market Goats shall be shown Slicked from hocks up ¼" or less. All others show haired. Memberships must be paid prior to the show to receive points for the IMGP buckle series or the ILWS.

Release & Waiver of Liability and Indemnity Agreement

In Consideration of being permitted to enter for any purpose any restricted area (herein defined as including but not limited to the racing surface, pit areas, infield, burn out area, approach area, shut down area, and all walkways, concessions and other areas appurtenant to any area where any activity related to the event shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, **each of the undersigned**, for himself, his personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he has, or will immediately upon entering any such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he enters and with which he comes in contact, and he does further warrant that his entry upon such restricted area or areas and his participation, if any in the event constitutes an acknowledgment that he has inspected such restricted area and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use, and he further agrees and warrants that if, at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the restricted areas:

1. **Hereby releases, waives, discharges and covenants not to sue** the promoter, participants, racing association, sanctioning organization of any subdivision thereof, track operator, track owner, officials, car owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "lessees", from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands thereof on account of injury to person or property or resulting in death of the undersigned, whether caused by the negligence of the lessees or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating in, observing, working for, or for any purpose participating in the event.

2. **Hereby agrees to indemnify and save and hold harmless** the lessees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the lessees or otherwise.

3. **Hereby assumes full responsibility for and risk of bodily injury, death or property damage** due to the negligence of lessees or otherwise while in or upon the restricted areas and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

Each of the undersigned expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. Each of the undersigned further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
